MOTORIZED AND NON-MOTORIZED BOATS

The State of Illinois requires MOTORIZED and NON-MOTORIZED boats to be registered. The Little Swan Lake Club requires all MOTORIZED (gasoline, gasoline/oil mix) or NON-MOTORIZED boats to be registered with the Club and to carry a Club decal. Lake limitations on horsepower are found in the *Club Rules and Regulations: Summer and Winter Sport Rules*, Boating, #11. Note: Air boats, jet boats and personal watercraft are prohibited. The committee reserves the right to inspect any boat, motor or sport vehicle before or after a permanent season decal is issued if questions arise regarding a boat or motor's compliance with size horsepower rules or a sport vehicle's compliance with LSL Club Rules and Regulations. Any current member whose dues are paid may request an inspection of any boat, motor or sport vehicle for good reason. The request must be made in writing to the LSL Boat / Sport Vehicle Review Committee Chairperson and state the reason the request is being made. If any false information has been supplied for the purpose of registering any boat, motor or sport vehicle not meeting the rules, the member supplying the false information will be suspended from lake privileges for that boat or sport vehicle and any other boat or sport vehicle for the entire season.
